Germania Brewing Company Building

Location: 200 Sixth Avenue, Cambria City, Johnstown, Cambria County, Pa.

<u>Description</u>: No. 200 Sixth Avenue is an assemblage of brewery buildings originally arranged around a courtyard. Ranging from two to five stories, all are constructed of brick, with flat roofs. The 1913 Sanborn map gives us an indication of the buildings' uses. The two-story building at the corner of Sixth Avenue and Bradley Alley had a bottling plant on the first floor, and storage of bottled beer on the second. The two-story building next door was the office building. The other two-story building on Sixth Avenue was the repair shop. The large five-story building, 75' high, had keg filling on the first floor and beer cellars above. The remaining buildings were used for brewing beer and storing it in kegs.

History: No. 200 Sixth Avenue was constructed in ca. 1907, according to deed records. The Germania Brewery was one of six in Johnstown by 1910. Cambria City was home to three breweries, including Goenner's, at Third Avenue and Power Street, and The Pittsburgh Brewery at 419 McConaughy. The Germania brewery operated here until 1919. With the beginning of Prohibition, the Germania company sold the building and all machinery to Louis Zang for \$38,000 in 1919. Zang sold the property to the Ferguson Packing Company two months later, for \$1.00. The Cambria County Sheriff seized the property in 1930. The property passed through the hands of several parties between 1930 and 1946. The Morris Electric Supply Company (after 1970, the Morris Paper Company; after 1977, Hammermill Paper Company) purchased the building in 1946.
