<u>Location</u>: 601-601 1/2-603 Chestnut Street, corner of 6th Avenue, Cambria City, Johnstown, Cambria County, Pa.

<u>Description</u>: Two-story, multi-family wood-frame structure. Horizontal wood siding, side-gable roof. Architraved flat-headed windows throughout. Rectangular plan, 48' x 30'. No. 601, situated on the corner of 6th Ave., is larger than the other two houses. It has a four-bay main facade, while nos. 601-1/2 and 603 are two-bay. All the dwellings have simple wooden porches projecting onto Chestnut Street. No. 601 also has a recessed porch on 6th Ave.

History: In 1871 Henry Abt conveyed this lot to John Casper Roth for \$1,140. The tax assessment for that year records Roth as owning one house on one lot. The 1880 census notes that Casper Roth, a laborer, and his wife, Elizabeth, were German and had four children. They had come to America in 1864. Between 1880 and 1884 Henry Yost owned the property and in 1884 Roth took over the property again. The 1887 city directory notes that Casper Roth who worked at the Cambria Iron Co. lived on Chestnut Street. The 1889 directory notes that eight of the Roth family living at 601 Chestnut Street survived the flood.

Between 1891 and 1895, Roth added two units, 601-1/2 and 603. The 1900 Census records that Elizabeth Roth, a widow aged 56, and five of her children lived at no. 601. A Hungarian family of four and two Hungarian boarders lived at no. 601-1/2. No. 603 was rented to a family of four from Pennsylvania. The men in both households all worked in the steel mill. The house stayed in the Roth family until 1931.
