Location: 105 Fayette Street, Westmont, Johnstown, Cambria County, Pa.

Description: Spacious, multi-gabled, wood-framed, single-family house sheathed with wood shingles. It has two-and-a-half stories with a brick chimney stack to the rear of the front gable. The hipped-roof porch is almost enclosed with large rectangular columns and high balustrade which are covered with shingles. There is a large projecting bay with three windows inside the porch area on the first floor. Wooden lattice-work is below the porch.

History: Fannie Morris, widow of Galloway C. Morris, purchased this property from the Cambria Iron Company for \$825 on April 8, 1891. She built her house here, on the corner of Fayette Street and Edgehill Drive, sometime before 1895 (according to 1895 tax assessment records).
