Location: 144 Fayette Street, Westmont, Johnstown, Cambria County, Pa.

Description: Massive two-and-a-half-story, wood-frame single-family residence situated on a large lot with an unusual carriage house behind it. The horizontal wood structure has a hipped roof with a front projecting gable which is ornamented with a half-round sunburst window crowned by a wooden keystone. The gable is further ornamented with a beaded edge as well as the underside of the main cornice of the house. The top portion of the two-over-two-light sash windows have diamond-patterned window panes. A large wrap-around front porch is supported by Doric columns that are connected by a balustrade composed of bulbus-shaped balusters. The elliptical fanlight and the two sidelights which surround the front door are filled with leaded glass.

In 1950 a 6' x 8' extension was added to the rear of the existing dwelling by a contractor, Richard Stager, for \$800.

<u>History</u>: On February 14, 1893, Harry S. Endsley, a lawyer, purchased this property from the Cambria Iron Company for \$1,575. Tax assessment records state that Endsley was taxed \$700 for his property in 1894 and \$3,500 in 1895, due to the construction of a house on lot 2. The 1900 U.S. Census lists Endsley as a lawyer who was born in 1855 in Pennsylvania. The city directory records that Endsley had an office at the Cambria Steel Company's general office on Washington Street in 1900.
