Location: 233 Tioga Street, Westmont, Johnstown, Cambria County, Pa.

<u>Description</u>: Large, two-and-a-half-story, two-bay single-family residence covered with wood shingles and resting on a concrete block foundation. The hipped-roof has a large shed-roofed dormer with three six-over-six-light sash windows. The shed-roofed front porch is supported by square columns covered in wood shingles and an enclosed wood-shingle balustrade. Wooden lattice-work under the porch area. The east side of the house has a two-story projecting pedimented gable. A one-story, shed-roofed enclosed porch is to the rear of the house.

<u>History</u>: This house was built in 1916. A. G. Raab, a draughtsman, purchased two lots here from the Cambria Iron Company on October 18, 1903, for \$2,000. He never built a house on either lot. In 1916, Minnie E. Wattingly bought one lot from Raab for \$600, and built the house the following year.
