Location: 314-16 Broad Street, Cambria City, Johnstown, Cambria County, Pa.

Description: Substantial three-story, commercial brick structure, measuring 24' x 79'. The principal facade has a modern storefront on the first floor with four bays in the upper stories. The windows on the second story are flat-arched and the sills and lintels are incorporated into stone string courses. Segmental-arched windows in the upper story have projecting brick arches. Above the arches are recessed brick panels. Projecting machicolated parapet with panel inscribed "S.C. Pollak 1905".

History: In 1899 Samuel Pollock [sic] bought from Rose B. Mulvehill (nee Keelan) a 25'-front lot on Broad Street, for \$2,300. Mulvehill had inherited the lot when her mother, then a widow, and four of her five children died in the flood of May 31, 1889. In April 1905 Samuel Pollak bought the adjacent lot from James Melvin for \$5,800. In the same year he erected this building which was used as offices and a meat market. It was designed by a prominent local architect, Walter R. Myton (1872-1929).

Paul S. Hornick bought the property from Samuel C. Pollak in October 1921 for \$38,000. Hornick had a hardware business there. The building is still owned by the Hornick family and is now a sporting goods store.
