2002-2003 In Review: Students' Accomplishments Bring Pride and Recognition


Students' accomplishments, talents, and contributions have brought pride and recognition to our district. Below are a few of the highlights of our school year, many of which are featured in greater depth within the pages of the 2003 Hilltopper Highlights.

District students were recognized nationally for achievement in academics and music and they advanced to state level competitions in Scholastic Quiz, forensics, mathematics, track, cross country, swimming, hockey, tennis, soccer, wrestling, music, and theater.

Prabhu Narahari achieved a perfect SAT score, and Michael Bukoski was named as a finalist. Zachary Gates and Zachary Pozun received letters of commendation for their performance in the National Merit Scholar Competition.

Two of our graduates, Dorothy Fink and Elijah Petersen, achieved national recognition by being named to the USA Today's Top 20 College All-Scholastic Team. No two students from the same high school have achieved this honor during the same year anywhere in the nation.

The Forensics Team won the District Championship and nine students qualified for state competition.

Isaac Kuhn won first place in the state of Pennsylvania in his competition.

Both Alexander Pozun and Jacob Seigh won first place in the Platinum Master's Division of 24 Challenge Math in their grade levels and ranked first in South Central Pennsylvania.

The district was honored continually this year for outstanding performing arts programs. The district was represented in District All-State Chorus, County Orchestra, All-East Honors Choir, and All-State ACDA World Music Honors Choir.

Jeffrey Goble won first chair status in the Bass 1 Section for the state of Pennsylvania.

Lydia McClain and Erin Sheridan each earned national recognition at the ACDA convention in New York.

Our high school Chamber Choir sang at the Kenny Rogers Concert.

The WHHS Theatre Club won Fourth Place at state level competition in drama.

The middle school Drum Line achieved the highest score EVER achieved in the Atlantic Coast Indoor Competition. (See page 7)

The middle school Percussion Ensemble won first place in the Atlantic Coast Indoor Championship. Westmont Hilltop School District won the Laurel Highlands All-Sports Trophy.

The Boys' Soccer, Hockey, and Tennis Teams reached new levels of competition by participating in the state championship playoffs.

The Boys' Tennis Team had an undefeated season and became District 6 Champions.

The Boys' Soccer Team won the District 6 Championship and finished in 2nd place in PIAA state level competition.

Conference Championship, had a 5th straight undefeated season, and represented WHSD at state level competition.

The Girls' Junior High Basketball Team won the Laurel Highlands Athletic Conference Championship.

Priya Narahari won the District 6 Girls' Singles Tennis Championship.

The Westmont Hilltop Hockey Team advanced to the State Championships and returned with a 2nd place trophy.

The Boys' Varsity Basketball Team won the LHAC Section 2 Championship.

Our Boys' Wrestling Team made us proud by receiving a special commendation for sportsmanship from James Herlinger of North Carolina.

Kaitlin Urban broke a 20-year school record in track and field, received LHAC and District 6 First Place Finishes, a PIAA State Track 4th place finish, and set a new LHAC meet record.

National Merit Scholar Awards

The National Merit Scholarship Corporation sponsors a nationwide academic competition each year based upon the results of the PSAT. Four of our seniors were recognized for exceptional academic performance on their junior year PSAT.

Zachary Gates and Zachary Pozun were honored with "Letters of Commendation" for their outstanding performances on the PSAT. They placed among the top five percent of the program entrants. To put that in perspective, they were among a group of only 34,000 students out of more than 1,000,000 to receive this honor.

In the next step in the competition, 16,100 semifinalists were designated nationwide. Both Mike Bukoski and Prabhu Narahari were named National Merit Semi-Finalists. Mike scored three perfect verbal scores on College Board exams, and Prabhu scored a perfect 1600 on the SAT. Both Mike and Prabhu were named National Merit Finalists.

Prabhu was selected as a National Merit Scholar. This award is one of the most prestigious awards that a high school student can attain. He will receive a \$2500 scholarship for this accomplishment. The last National Merit Scholar from Westmont Hilltop prior to Prabhu was a member of the Class of 1999.

Congratulations to these four students for representing Westmont Hilltop so well at the national level of National Merit Scholarship competition.







Academic "Best" Awards

The Academic "Best" Awards were presented at the June 3 Awards Assembly at the middle school. These awards are presented to 8th grade students who are chosen to represent the academic "best" in particular subject areas. Selection is always difficult, since so many students represent their own high standards of academic best. A \$100 Savings Bond was awarded to the "Best" in several curricular categories.

Recipients of the awards for 2002-2003 are: English – Chelsea Meenan; Math – Nikhita Dharbhamulla; Science – Andrew Morbito; Civics – Jason Catanese; Art – Alexander Bonini; Foreign Language – Rebecca Hirsch; Music – Lydia McClain; Physical Education – Ashleigh Kowtoniuk.

English: The student representing the academic "best" in this category must demonstrate scholarship, leadership, a positive attitude, class participation, responsibility, accountability, dependability, and initiative.

Math: The student must participate in the PACE program; consideration is given to both aptitude and achievement test scores; classroom performance will be evaluated; and outcomes of any appropriate contests will be considered.

Science: The student must have an "A" average for three quarters; participate in all aspects of class (lectures, labs, question/answer, discussions); demonstrate leadership, respect for others, responsibility, reliability, and a mature attitude.

Civics: The student must demonstrate scholastic high achievement;

citizenship as demonstrated through in school and community service; and must show initiative through class participation.

Art: The selected student must display good citizenship and class participation; have a positive effect on peers; exhibit a high level of creativity, and demonstrate a significant level of improvement/ achievement.

Foreign Language: The academic best in this category must achieve 95% in each of three quarters; demonstrate excellent class participation and a positive classroom attitude; and demonstrate classroom leadership and reliability.

Music: Participation in at least one ensemble is required for this award, along with superior grades in general music class; the student must possess leadership, responsibility, a positive attitude, and dependability.

Physical Education: The student selected in this category must display a positive attitude toward physical education; participate to the best of ability in all activities at all times; score, at the least, the average requirement on the National Physical Fitness Test for fitness; maintain a sense of game; and demonstrate responsible, respectful behavior as a team player.

American Legion Awards

This award is presented by the American Legion Auxiliary to one 8th grade boy and one 8th grade girl. Recipients of the American Legion Awards for the 2002-2003 school year are Jason Catanese and Stephanie Keklak. The criteria used to select the recipients are listed and defined below.

Honor: Strength and stability of character, high standards of conduct, keen sense of what is right, adherence to truth and conscience, and devotion to duty.

Scholarship: Scholastic attainment, evidence of industry, and application in studies.

Service: Kindness, unselfishness, willingness to lend a helping hand, protection to the weak, and preferment of the interests and welfare of associates - without hope of personal reward.

Americanism: Active interest in promotion of love of country, as may be expressed in formal exercises, respect to the flag, knowledge of the National Anthem, the flag salute, adherence to the country's highest ideals, and worthy citizenship.

Leadership: Ability to perform the duties of leadership assigned to one as exemplified in holding of office, committees, etc., and exhibition of good team play.

Courage: Moral courage to stand up for what is right, and physical courage in games and play.

24 Challenge Math Team



Math Counts Results



Special Events

Grade Six Medieval Times

The 6th grade social studies curriculum provided the vehicle to emphasize the Medieval Times. In this interdisciplinary unit, the students analyzed the Medieval Period. Students utilized communication skills and used primary as well as secondary resources in the writing process to explain how relationships between politics, government, and religion influenced the way in which the people of this time lived. Students experienced European life in the Middle Ages by participating in a variety of Medieval Times simulations. Structured activities reinforced the understanding of the Medieval Time Period and its impact on today's society by comparing and contrasting aspects of this time period with those of the present.

Students traveled back in time to a period in Western Europe when no central government existed, nobles ruled vast areas, and peasants were dependent on the generosity of these ruling nobles. During the Middle Ages new ideas and learning were limited, but students of the sixth grade did not experience this lack of knowledge acquisition. Students used research to learn about their family names. While learning about heraldry, students had the opportunity to design, create, and display shields representing their family lineage. Language Arts' assignments used life in a Medieval castle and village as their focal point for reading, writing, and responding. Learning continued as the sixth grade students chose other areas of interest for further development. In science classes, the students researched topics prominent during the Middle Ages, like medicine, navigation, astronomy, cook-

ing/food, mathematics, scientists, machines, castle offense and defense, diseases, and weaponry. The students then designed and built their own visual aids. Other activities included period dance, period games, and other daily activities. The student projects depicted life during Medieval Times.

On April 11, 2003, the culmination of the learning experiences drew to a close with actual events of



The cost for the photographs is \$1.00 for a 4" X 6" print and \$2.50 for a 8" X 10" print.





Budget Perspectives

Facing the challenge of the budget for the 2003-2004 school year, the district confronted the following facts:

The proposed operating budget for 2003 – 2004 totals \$14,957,300, representing an increase of \$587,000 or 4.2% over the previous year. Noteworthy expenditure increases include:

- Employer Retirement/Social Security Contribution - \$112,500
- Health Insurance Premium -\$356,000
- Special & Regular Transportation - \$31,500

Noteworthy expenditure decreases include:

- Tuition to Vo-Tech \$38,000 decrease
- 5% reduction in each of the following: Maintenance, Technology, Student Activities, and Instructional Supplies & Equipment

A 5.0 mill real estate tax increase is required to fund the budget. The real estate tax millage rate for 2003 – 2004 will total 126.25. The 5.0 mill real estate tax increase translates into an average increase of approximately 55 dollars per residential taxpayer. One mill of real estate tax generates approximately \$62,500.

Our school district continues to receive minimal support from the state. Westmont Hilltop School District's Basic Education Funding from the Commonwealth of Pennsylvania will total \$2,367,365 in 2002 – 2003, or approximately \$1,394 per student. The average state funding per student in

Cambria County is \$4,129. Our school district receives \$2,734 less per student than the Cambria County average.

The district continues to struggle with the increased cost of providing state-mandated programs such as cyber charter school payments; property, health and liability insurance; and general operating increases, while receiving minimal state subsidy increases. Approximately 80% of the school districts in Pennsylvania receive more state subsidy per pupil than Westmont Hilltop.

The district's total expenditures per average daily membership of \$7,438 during 2001 – 2002, the most recent data available, reveal that our school district spends approximately \$51 less per student than the Cambria County average. This statistic indicates that the Westmont Hilltop School District is operated in a cost efficient manner in comparison with other local school districts. The Board of Education and the administration remain committed to providing a quality educational program while maintaining sensitivity to the burden on the resident taxpayer.

During the past several years, our district has been one of the few districts in our area that has experienced a modest increase in student enrollment. During this same period, the district has taken serious measures such as a 5% reduction in discretionary spending to minimize the effect of limited state subsidy, the drastic retirement rate increase, health insurance increases, cyber charter school payments, and

general operating increases. The board and administration has continued to request that the state recommit to its obligation to adequately fund our public schools in a fair and responsible manner.

Because of the inequities in the state funding system, local tax sources account for approximately 70% of the district's operating budget. With virtually no commercial tax base and limited new housing construction in the district, resident property owners continue to bear the cost of budgetary in-

creases. School district representatives have lobbied state legislators to increase the amount of state support for public schools and to distribute funding to schools in a fair and equitable manner. They also have

requested that state legislators sponsor and support legislation to allow districts the flexibility to pursue alternate means to raise revenue and alleviate the heavy financial burden that local property taxes impose on property owners. The following is a communication from the Board of Directors that was delivered to Governor Rendell and Secretary of Education, Dr. Vicki Phillips.

Perspectives on Governor Rendell's **Proposal for Education**

Westmont Hilltop School District 827 Diamond Boulevard, Johnstown, PA 15905

Introduction

The purpose of this paper is to provide perspectives specific to the Westmont Hilltop School District related to the governor's proposed education funding initiatives. The proposal impacts districts differently depending on the aid ratio and the revenues that the district can generate.

We applaud the state's initiative in bringing the basic education funding to the 50% level. It has been impossible for our district to keep pace with the cost of health insurance, retirement costs, and general operating costs without raising taxes every year, despite the fact that we have operated under a directive of no increase in discretionary spending for the past seven years. That represents an approximate 14% cut in operating expenses based on a cost

of living adjustment of 2% per year. We are at the point of looking at potential program and staff reductions that would negatively impact our educational programs.

The Westmont Hilltop Context

The Board of Education and administration operate the school district in a fiscally responsible and cost-effective manner. The following comments were extracted from the recent Standard & Poor's analysis of our school district:

Relative to other school districts in Pennsylvania, the Westmont Hilltop School District (WHSD) achieves well above average student results with spending that is comparable to statewide levels. The district's spending per student is comparable to the state average, but lower than the average of a group of peer districts with similar results. During the period examined, the district's per student operating expenses were less than the state and peer increases. On a per student basis, the district's instructional expenditures are moderately below the state average and lower than the peer group average. In the state of Pennsylvania, only 18% of schools receive less per student revenue from state sources than the WHSD. The district's comparatively high tax burden results from low state funding and reliance on local sources.

The proposed .95% increase in the PA income tax would mean a total increase of 2.9 million dollars for our district wage earners; whereas the real estate tax reduction would result in a 1.5 million dollar savings to residential property

owners. This money being raised locally will be distributed to other districes with higher fund balances, state aid ratios, and greater higher access **1**0 funding resources and grants **1**hat favor some districts. Appro imately 26% of our district reside ts are 62 years of age or older. Senior residents, many of are retired and live on fixed whom incomes, must bear the burden of tax increases needed to annual adequately fund our school district.

Under the governor's proposal, our district would receive only a \$78,53 increase in basic education subsidy. The \$287,000 increase for full day kindergarten would not cover the costs of this initiative, where other districts currently offering full day kindergarten will receive windfall. The overall increase in the tax burden for district esidents under this proposal is \$890, 430. If it costs the district and its esidents more money to accept the funding, there is really no benefit for our district.

Num erous school districts with a large surplus in their fund balances are receiving the greatest state funding This system is unfair to those districts, such as ours, that must an ually choose between increasing real estate taxes, depleting a modest fund balance, or eliminating educational programs to balan e the budget. We propose that a reasonable cap on a district's fund balance be used to determine the need for additional funding from the state. This process could conceiva by create a pool of monies that could be more fairly distributed to those who historically have had no alternative but to raise local property taxes to maintain educational excellence.

Our Proposals

We propose that districts be allowed the flexibility to increase earned income tax without the constraints imposed by Act 50. This would allow districts such as Westmont, with a large number of retired residents and residents on fixed income, to distribute the tax burden more fairly to the wage earners within the school district. Alternatively, we suggest the investigation of other taxing options, such as a sales tax, that might result in a more equitable distribution of the burden.

We propose that full-day kindergarten and pre-school programs have far less of an impact in a district where most kindergarten students enter school having been to one of several local pre-schools that are preparing our students well. Most of our kindergarten students enjoy enriching home lives where parent involvement and concern for the educational process is high. Students benefit from the time they spend with their parents at this early age. In situations where this ideal does not prevail, we have made arrangements, through the Instructional Support Team, for the student to receive an extended day.

We request to be able to use the \$287,000 increase currently designated for full-day kindergarten to reduce class size in K-3, a major issue for our district, and one that would tremendously benefit our students. We are currently considering a program reduction in order to bring about reduced class size within the restrictions of our budget.

While the proposed education budget continues to provide funds for charter school start-ups, no funding is proposed to encourage school districts to explore funding incentives for mergers or consolidation of services. Consider a freeze on any new charter school development and include funding for district mergers and consolidation of services.

Summary

In summary, the Westmont Hilltop School District has taken serious measures such as a spending freeze and other initiatives to minimize the effect of limited state subsidy, the drastic retirement rate increase, cyber charter school payments, and general operating increases. The board and administration of the Westmont Hilltop School District respectfully request that the Commonwealth of Pennsylvania re-evaluate the financial burden placed on local school budgets by the Commonwealth and recommit to its obligation to adequately fund our public schools in a fair and responsible manner.

It is unreasonable to assume that with 501 school districts, each with their own distinct populations, demographics, educational needs, and distinct financial characteristics, that a one-size-fits-all solution is possible. We therefore encourage flexibility in decision-making and freedom for locally-elected boards of education to represent the will of the public in meeting the educational needs of the community.
