District Level Initiatives

Strategic Planning 2001-2006

In the fall of the 2000-2001 school year, the Westmont Hilltop School District entered into Strategic Planning to develop a six-year plan to guide our process in serving the needs of our students through 2006. Our Strategic Plan was based on an analysis of internal and external needs that led to the establishment of priorities and action plans. The planning process involved community members, business leaders, students, educators, and school officials in this vital effort. Within this collaborative partnership, the Strategic Planning Steering Committee and its subcommittees charted a course of action to ensure that ample and appropriate consideration be given to the educational needs of every student in the district.

Our purpose throughout the accomplishment of the goals of the plan has been the reinforcement of a collective commitment to the continual upgrading of our educational offerings. This is accomplished through the setting of high expectations for all students while providing the necessary structures and supports to ensure the achievement of our educational goals.

The fulfillment of the plan has involved all members of the district in all curricular areas as we worked together to optimize learning opportunities for the students of the Westmont Hilltop School District. The plan reflects our commitment to the present and future success of our students and the collective responsibility we assume for ensuring that success.

A midpoint review for purposes of accountability was accomplished in February of 2004 with the same committee that created the plan. We are pleased to announce that the plan will successfully conclude, having served five priority goal areas as follows: curriculum, safety, staff development, technology, and community partnerships.

A Few Highlights and Accomplishments

Whereas the accomplishments of the past five years would take more than a single publication to list, all are ultimately attributable to the outstanding commitment of the faculty and students of the Westmont Hilltop School District in partnership with the leadership team and community; therefore, we wish to emphasize these for our community. A few highlights of accomplishments during the course of the plan are as follows:

Curriculum



- Planned Courses were aligned with state standards and published by all faculty members followed by online publication,
- allowing district-wide access to all courses of study.
- Cross-Grade Level Alignment was undertaken and included recommendations for differentiated instruction across all departments.
- PowerSchool is in its fifth year of implementation and provides online access to grades and progress updates for students in Grades 5-12, and Grade 4 is planning a pilot project to be announced soon. The system of parent/teacher conferences is still in effect and highly valued for our elementary students. We thank Mr. Joseph Molnar, Mr. Matthew Thomas, and Mr. Roger Cowder for their individual contributions in this initiative.
- PowerSchool will be piloted at the elementary school in Grade 4 under the direction of Principal Peggy McDonald. A local assessment for the PSSA was developed at the high school level under the direction of Principal William Marshall.
- An online system of monitoring progress is now being piloted at the middle school under the direction of Principal Carole Kakabar.

- A system of recognition of student scholarship, service, and achievement was developed and carried out at the board level, through recognition certificates presented in each building, and culminating with the Hilltopper Highlights, a summer publication exclusively dedicated to student success.
- An online student registration format has been implemented for grades 8-12.

Safety



- An Emergency Response Plan was implemented and has been updated annually. We continue to monitor the effectiveness
- of our safety planning through the Pennsylvania Youth Survey and the Olweus Bullying Prevention Program. We acknowledge Director of Education, Mr. Steven McGee, for his leadership in these initiatives.
- The Student Assistance Program was extended to the elementary grades and is now in effect from K-12. Those programs have been enhanced through several community partnerships, including mental health services and others included in the Community Resource Directory published through the Office of Community Health.
- We have installed Automatic External Defibrillators (AED's) in all three buildings and committed to cyclic training in the use of them as well as training in Cardio Pulmonary Resuscitation (CPR). An AED is a compact and portable machine designed to assist first responders in treating a person who is experiencing sudden cardiac arrest.
- The Administrative Team worked with the Special Emergency Response Team to address a variety of preparedness scenarios, and we have reviewed memoranda of understanding with police, ambulance, fire, and health agencies.
- Emergency Broadcast radios and walkie-talkies have been purchased,

- and updates of new technology and procedures are provided annually.
- Building Maps and Key Locations have been provided to local emergency response teams thanks to the initiative of Facilities Manager Mr. Daniel Ream.



Staff Development

- An Act 48 (teacher staff development process) was put in place and has been implemented.
- Technology-based staff development offerings have included PowerSchool, Web Quests, and an Electronic Calendar/Homework program.
- Safety programs have included sessions for all staff in mandated reporting and confidentiality, non-violent crisis intervention, first aid, CPR/AED use, and emergency situation information.
- All teachers have been provided with a Crisis Response Handbook that includes emergency numbers and school policies and procedures for a variety of emergencies.
- Bullying prevention initiatives continue in grades K-8, and information regarding harassment and a series of informative sessions on Positive Peer Interaction have been carried out at the high school level.
- All faculty and staff regularly engage in HIPAA training (in compliance with the Health Insurance Portability and Accountability Act).
- Administrators, key faculty members, and guidance counselors have been engaged in a review of the special education process.
- District administrators have hosted faculty from other districts in observations of the block schedule, differentiated supervision, and the Everyday Mathematics Program.
- Elementary and fifth grade middle school staff have been involved in a collaborative effort with the Ferndale faculty in which the type and timing of balanced literacy instruction has been the focus. Principals Peggy McDonald. Carole Kakabar, and Assistant Principal Nicole Kuzmiak have provided leadership for our district.
- A process of differentiated supervision

- (through which teachers participate in a variety of self-directed and collaborative offerings, depending on their level of professional development) was formally adopted by the board during the course of the current Strategic Plan, following a two-year pilot prior to that adoption.
- All teachers met the Pennsylvania
 Department of Education's requirement for continuing professional development.



Technology

- Under the direction of Technology Director, Mr. Joseph Molnar, a replacement cycle
- was established and implemented for the upgrading of all servers, printers, and work stations in the elementary, middle, and high schools.
- A wireless lab and an expanded computer lab in the middle school library have allowed for specialized instruction and achievement monitoring in an online forum.
- Digital Light Processing equipment was added in strategic locations including labs and large group instruction classrooms to assist in delivery of curriculum and access to multimedia presentations.
- A new website that offers information specific to individual building levels (elementary, middle, and high schools) and provides a variety of district-wide announcement opportunities has been established.
- The District's Acceptable Use Policy
 was updated to reflect changes in new
 technology and safety monitoring to
 address new vulnerabilities and threats
 that schools face when providing
 internet access. Students and parents
 review and sign these at key transition
 points including entry into school and
 at two transition points thereafter.
- A "Help Desk" (an electronic means of requesting help from maintenance and technology personnel) was established to provide teachers and administrators with the opportunity to post needs and concerns that are immediately accessible by technology

- personnel as well as those responsible for buildings and grounds. This access enables personnel to address needs and concerns earlier than previous methods.
- An online facilities calendar has been published, giving the public access to our calendar of events for events related to scholarship, the arts, and sports.
- A three-year technology plan was designed, based on the Strategic Plan, and was approved by the Pennsylvania Department of Education.
- Accelerated Reader, an online reading assessment database, was expanded and redeployed through the eighth grade.
- An additional bank of computers in the high school library was needed to accommodate the high school students' increasing needs for access and utilization. A new fully functional lab for student and faculty use was established at the high school.
- New industry standard technology hardware and software applications have been employed (such as stateof-the-art computers, a Microsoft Exchange Server, and Internet Security Acceleration Server, and a PeachTree Accounting Software).
- Our Wide Area Network was upgraded to a full one gigabit per second, which increases efficiency and speed of communication among buildings. This has resulted in a much more reliable network and doubled the speed of our internet connection from one to two megabits per second.
- Network controls, web filtering, and monitored quotas have been employed to maximize efficiency and reduce cost.



Community Partnerships

 The district is building upon existing collaborative ventures while

initiating new ones in an effort to broaden students' experiences beyond the classroom. The district is committed to supporting students in service-oriented projects that have

benefited organizations such as the Salvation Army, Women's Help Center, the Remembering Adam Foundation, and Outdoor Odyssey. Some examples have included Connecting with Kids, hosting community programs such as ACRP at the elementary school, and the Salvation Army Kettle Drive and Soup Kitchen.

- Partnerships are in place with the Child and Adolescent Health and Wellness Council, the Student Assistance Program, local Police Departments, and the Department of Emergency Services. Services are extended through MH/MR-CYS, ACRP, and Victim Services.
- Students have contributed services and/or participated in educational programs with Carnegie Mellon, Johns Hopkins, the Second Mile Challenge Program, the Twin Lakes Drug & Alcohol Center, Highlands Reenactors of the Civil War, the Cambria County Court House, Remembering Adam Foundation, Women's Help Center, and many others.
- Student Assistance meetings regularly involve representatives from MH/MR and the County Drug and Alcohol Program. Other partnerships have included community outreach and education programs sponsored by our Key Club and National Honor Society.
- Kyrus Lunchbox is an online service that provides parents with daily updates on lunch balances and potentially provides for parental control over student lunch selections.
- Student Teacher exchanges take place regularly with the University of Pittsburgh at Johnstown, Indiana University of Pennsylvania, St. Francis University, and St. Vincent College.
- A Community Resource Manual is published through the Office of Community Health and is housed in Central Administration, providing phone numbers and access to community resources on an as-needed basis.
- High School Students engage in work/ study release with a variety of local businesses.
- A new partnership has been established with the Pennsylvania Highlands Community College for dual enrollment, and concurrent enrollment opportunities with local colleges are

also available upon administrative review.

New Strategic Planning Process to Begin in 2006

A new Strategic Planning process will begin in September of 2006. We will be involving community members in this important initiative at the start of the new school year. As always, we look forward to the talents and expertise that are shared by parents and community members and the partnerships within our community that will support and enhance our school system as we plan together for the future of our school district.


Current Initiatives for 2006

Initiatives now underway in our district include the following:

- Teachers are engaged in monitoring progress of students through local assessments, new online programs, and the PSSA to inform our process of curriculum development and instructional design.
- Teachers are engaged through department teams and grade levels in

- refining the alignment of all courses from Kindergarten through Grade 12.
- Supervision opportunities are designed to provide options for teachers at differing stages of professional development.
- An advocacy program for district-wide summer reading is underway.
- Student support systems are under review for the purpose of ensuring that all students make Adequate Yearly Progress.
- Health, Safety, and Welfare Planning including 911 preparedness, CPR, and AED training continue as major initiatives.
- New procedures for providing differentiated instruction (in the form of support for students in attaining proficiency and extended opportunities) for students in need of learning enrichment are continually under review.
- Legalities of the IEP, inclusive practice, and No Child Left Behind Requirements are topics for new training initiatives.
- Coordinated Health Planning (covered in detail below).

Coordinated Health Planning



When we talk about the purpose of schooling, we talk about high quality educational experiences delivered within a safe, nurturing environment. When children are healthy and safe, they can learn. When they are not, learning is severely impeded. It is the obligation of schools to provide a safe, nurturing environment. Comprehensive health planning will ensure that we can provide the environment in which high quality education will thrive. The law, Section 204 of Public Law 108-265--June 30, 2004, requires each district to enact a wellness policy by the first day of the

2006-2007 school year. (This is the Child Nutrition and WIC Reauthorization Act of 2004.) During the 2005-2006 school year, districts must focus on the development of wellness policies through district-level committees or School Health Councils that will develop the policy. Parents, students, teachers, school food service staff, the school board, school administrators, and the public must be involved in the planning.

After establishing our local advisory councils for the local wellness plan, district representatives attended several orientation sessions for the development of a local assessment. Our district's council is composed of representatives of the community and school board, students, parents, teachers, educational specialists, school nurses, food service personnel and administrators. Dr. Matthew Masiello, Mrs. Diana Schroeder, and Mrs. Donna Wehner are serving as regional coordinators of comprehensive

Westmont Hilltop Students Exceed No Child Left Behind Requirements

Westmont Hilltop's Grades 3, 5, 8, and 11 students once again exceeded the No Child Left Behind (NCLB) requirements on the PSSA during the Spring 2005 testing. District students scored above the state average in both reading and mathematics at all four grade levels.

Pennsylvania established Adequate Yearly Progress (AYP) Goals prior to the Spring 2002 PSSA assessments. The Spring 2005 AYP Reading target goal was raised to 54% - up from 45% in 2003 and 2004, and the Mathematics target goal was increased to 45% - up from 35% in 2003 and 2004. The chart also indicates yearly target goals through the spring of 2014, at which point 100% of students tested are expected to score at the proficient and advanced levels, according to current Department of Education expectations.

For 2005, districts were meeting AYP Goals if 54% of students at each grade level tested scored at the proficient or advanced levels on the Reading Assessment and 45% scored at the proficient and advanced levels on the Mathematics Assessment. As the accompanying chart reveals, Westmont Hilltop students exceeded both Reading and Mathematics AYP target goals at all four grade levels that were tested.

Two other important No Child Left Behind targets are PSSA participation rates and student daily attendance. 98% of Westmont Hilltop students took the PSSA in 2005. The state set 95% as the minimum acceptable standard for the PSSA participation rate. Our graduation rate of 99% exceeds the state minimum target of 80%.

Additional data was provided to school districts to enable educators to address the special needs of various subgroups within the school community. Subgroup data is provided for students in the following categories: White, Black, Latino/Hispanic, Asian, Native American, Multiracial, IEP (Individual Education Program), LEP (Limited English Proficient), Economically Disadvantaged, Migrant, Male, and Female. According

to present state guidelines, schools can fail to meet AYP if one or more of these subgroups fall short of the target goal. The district is working toward continual improvement for each of our subgroups and for all students in order to maximize individual potential.

The Class of 2005 and the SAT I

It is noteworthy that 84% of the Class of 2005 took at least one SAT examination. This is a higher percentage than most districts experience—evidence of the high value students and parents in our district place on their post-high school aspirations.

Westmont Hilltop School District Endowment Fund

An important resource to support the needs of our students and community is available through the Westmont Hilltop School District Endowment Fund. The members of this council are engaged in a process designed to significantly advance the mission of the district by focusing on the health and safety of our educational community through each of the following avenues: 1) health education, 2) the physical education curriculum, 3) health services. 4) nutrition services, 5) family and community involvement, 6) promotion of a healthy school environment, 7) health promotion for staff, and 8) counseling, psychological, and social services. We believe that a healthy school environment is an essential prerequisite to the provision of high quality educational experiences for our students.

Pre-assessment of strengths and needs has taken place and will now be followed by goal setting and action planning. Our completed plan will be submitted to the Pennsylvania Department of Education in September of 2006.

Westy Winners for Hurricane Relief Efforts

The Westmont Hilltop School District students and faculty have been extremely successful in their efforts to raise money for victims of Hurricanes Katrina and Rita. All three buildings had fundraising activities running through September and October. A list of these activities to date follows, by building.

Sources of Funding

During the 2005-2006 fiscal year, the Westmont Hilltop School District will receive funding from federal sources, required to be publicized, as follows:

Title I, Part A provides our kindergarten Title I program. Title II Part A Class Size Reduction provides a portion of an extra teacher's salary in the elementary school. Title II Part D contributes toward in-service training for faculty. Title V Part A allows us to acquire technology hardware for classroom use.

The Safe and Drug-Free Schools Grant contributes toward the salaries of aides, especially in the efforts to reduce bullying and harassment situations and compensation for tutoring services for students who may be academically at risk.

We will receive funding through the Individuals with Disabilities Education Act in the amount of \$193,418 that has allowed us to retain a new special education teacher and aides for a second year.

Post Act 72 Decision Update

The implications and complications of Act 72 were thoroughly studied during the spring of 2005 as they applied specifically to our district. This information was reviewed at a public meeting and published on the district website to invite public input and comment. Finally, a decision against opting into the provisions of Act 72 was made in the best interests of the district.

Due to the current funding formula, which determines the amount of state and federal aid that a school district receives, our district receives less than 30% of its total funding from the state and less than 1% from federal sources. The county average is 62% for state funding and 4.3% from federal sources. Our district receives less than any other school district in the county.

As a result, the local tax effort continues to be a challenge for our community. Despite this, a study of fiscal management conducted by a private consultant reveals that our district has averaged far less in tax increases than the Act 72 index would have allowed during the course of the past five years.

The state recently certified the allowable index for Act 72 purposes. The base increase allowed for 2006-2007 is 3.9%. Under Act 72, our district would be allowed to increase real estate taxes by 4.6% or 3.1 mills (the equivalent of 6.2 mills under the previous 50% assessment ratio).

Fortunately, we will not be constrained by the negative aspects of Act 72, and we will continue to make every effort to manage our budgets well under the allowable index. Meanwhile, our district continues to advocate for meaningful tax reform that is fair and equitable for our district as well as for all school districts throughout the Commonwealth.

Guidance counselors keep us out of *Jeopardy...* although, on rare occasions, one could take us into *Jeopardy!* Our very own Debbie Chuba is a case in point.

On December 20 of this school year, Debbie Chuba appeared on Jeopardy for an impressive performance that made us all proud. The magnitude of this accomplishment is obvious when we realize that in order to enter the selection process for Jeopardy, contestants must first pass a test. The test is a 50question written test projected on a screen. Potential contestants have 8 seconds to answer each question on this extremely challenging test. After that, all contestants who did not pass the test are dismissed from the room, and those who pass play a mock round of Jeopardy as an additional screening procedure.

Of the 24,000 people tested each year only 400 are selected for the show. Of 67

people who took the test in Pittsburgh last October, only four people passed (three others and Miss Chuba). Even when a potential candidate passes the test, there is no guarantee that he or she will be on the show. For example, of the four who were referenced above, only 2 have been on the show!

Debbie amassed over 17,000 points in the televised show, finishing second. She didn't miss a single question — even in *Final Jeopardy!* She made all of us in the Westmont Hilltop community proud. As one former student wrote:

The most valued prize in hockey made an appearance in the Westmont Hilltop School District this fall.


Transported in its own mobile cart, under lock and key, and surrounded by protective felt, the trophy was guarded by Mike Bolt, the personal "Cup Keeper" for this priceless artifact.

Since its donation in 1893 by Lord Stanley of Preston, then governor of Canada, the cup has symbolized hockey supremacy while gathering a series of amazing adventure stories in its travels. For example, in 1961, the cup was on display in the lobby of Chicago Stadium when a Montreal fan smashed its case and tried to abscond with it. His reason, which he revealed when his escape was foiled, was that as a native of Montreal he thought it should be returned to its rightful home, which he deemed to be Montreal!


The original cup is displayed in a former bank vault in the Hockey Hall of Fame in Toronto, having been replaced by an exact replica in 1967 in an effort to preserve the original. The Stanley Cup championship brings with it the opportunity for all the team's players to "host" the Cup for one day. Preservation efforts have been needed because during its long history, the cup has been displayed at numerous victory parties. lost, abandoned, used to store letters and bills, and stolen from the Hockey Hall of Fame in 1970! The Johnstown Chiefs' parent club, the Tampa Bay Lightning, was the 2004 winner of the Stanley Cup. That affiliation with Tampa Bay initiated a request by the East Coast Hockey League (ECHL) for a tour of all of the league's cities, beginning in Johnstown.

Thanks to the Chiefs for their invitation to view hockey's greatest prize. The next time you watch a National Hockey League Championship that ends with the winning team skating a victory round with the Stanley Cup held high over their heads, remember that the trophy's adventures have a long history, and that history includes an historic appearance on our very own Hilltop!

Students Pose With Hockey's Greatest Prize





School Cancellations Will be Posted on the Web

Visit the main web page of the district at www.whsd.org for district status and information. School cancellations and closings will be posted at that location on the web if possible. This information will also be broadcast through local media resources. Inclement weather conditions forced a cancellation of school on Friday, December 9. This day will be made up on Friday. May 26. In the event of additional school cancellations, three more snow days have been designated in advance and will be taken in this order if needed: February 20, April 13 and April 17. If cancellations do not occur prior to each of the designated snow days, then those dates will be vacation days for students and teachers.

We remain in a consortium with six other districts, and we operate on a common calendar. The need to cancel school in several districts results in closing for all; therefore, school closings are more likely than they have been in years past. The revision of built-in snow days in the calendar this year is intended to avoid a situation in which snow days are tacked on to the end of the year resulting in the need to move the date of commencement repeatedly, in uncertainty for upperclassmen regarding the start of summer employment dates, and in conflict with pre-scheduled vacations. We hope that this format will prove more convenient for our Westmont Hilltop community.
